Summary of Speech of the Khalifatullah Hazrat Munir A. Azim (1164)

22 July 2011 ~ 21 Shabaan 1432 Hijri (after Esha Prayers)

After greeting everybody with the Salutation of Peace in Islam, the Messenger of Allah (atba) read the Tashahhud, Taouz, talked about the qualities of an Imam coming from Allah and then talked about the prevailing political situation in Mauritius:

THE CATASTROPHIC UPROAR CONCERNING THE MINISTER OF HEALTH MRS. MAYA HANOOMANJEE/ CORRUPTION IN AHMADIYYA JAMAAT

She had to present herself in front of the Independent Commission Against Corruption (ICAC) on Wednesday 20 July 2011. She showed herself to be very brave on the media, but then at the time when she had to be presented to the ICAC, she declared that she had a breakdown and she refused to give an exact declaration to ICAC – she got a "pain"/"felt unease and sickness" and was admitted to "Apollo Bramwell" Hospital in Moka (spending one night and one day there).

Mrs. Hanoomanjee is a member of the MSM (Mouvement Socialiste Mauricien) party. Her colleagues paid her a visit, but not a member of the MSM's alliance party – the Labour Party. The President of the Republic was also present at the hospital (Wednedsay night). About 6.45 am on Friday she left the hospital and she forwarded to ICAC to clarify the "Medpoint" crisis (from June to December 2010). She was at the ICAC for about 90 minutes, then she went to the Supreme Court (No.3) where she was questioned by the Magistrate. As she was under arrest, she paid a caution of Rs.25,000 and signed a bill (acknowledgement) of debts of Rs.100,000 to free herself from the bondage of prison. The serious charge which the Prevention of Corruption Act (PoCA) has against her is as follows: "She did whilst being a public official, wilfully, unlawfully and criminally, makes use of her position for a gratification of another person."

Six persons, including her have been inculpated with a very serious charge sheet. These people include the Permanent Secretary, Principal Assistant Secretary and the others. The inflated cost of Rs. 144,7 millions is the actuality for the buying of "Medpoint". Now, Rs. 144,7 millions! Is that a meagre sum of money? She attended court in Port-Louis, then she came back to the hospital (spending 3 hours there), and then went back to the ICAC for further hours.

Moreover, the Khalifatullah precised that on Friday 7 January 2011, he already said that there shall be Ministers (and members of the parliament) who shall fall ill. Verily, this state of matters came to be. There was a Minister who had cardiac problems and had to change Ministry. There were verily many mourning for both the members of parliament (and their family) and now the sudden illness "malaise" overtaking Mrs. Hanoomanjee (due to the "Medpoint" crisis).

All this points to what this verse of the Holy Quran specifies:

"Corruption has appeared in the land and the sea on account of what the hands of men have wrought, that He may make them taste a part of that which they have done, so that they may return." (30:42)

These people have made large embezzlements and that with the money of the people! What a dreadful amount disbursed from the public fund!

This comes parallel with what has transpired in the Ahmadiyya Jamaat in Mauritius, when the ex-so-called Amir of that community dilapidated huge amounts of money from the funds of the Jamaat. Whenever he had to take out money, he asked permission "with the drawer of the Jamaat" – please can I take out money for my own use? Moreover, he did not hesitate to draw dishonoured cheques in favour of taking money from the drawer (funds) of the Jamaat. That man needed everything: brand new car, tickets to attend Jalsa Salana in England and elsewhere, and bodyguards (thus imitating his Khalifa in London). How could the Khalifa have tolerated such an Amir and is still

tolerating him in the Jamaat, by just removing him from a "sofa" and putting him on a "chair"? The Khalifa is still honouring him (whereas he is the mastermind of great calamities)? Does he not mind about the huge amount of money stolen? That man is still found in the Jamaat. The same happened in London when those around the Khalifa committed fraud. Now, I have said it in the past and I shall repeat it: bear in mind that this man's (Mr. the Hypocrite, being the mastermind of evils and corruption) downfall shall not stop at his being degraded from the position of Amir. Indeed his destruction has just begun. More destruction shall befall him (in all ways).

We are seeing a flimsy comparison between mundane and spiritual matters. That which befell Mrs. Hanoomanjee (and others) because of corruption, definitely that ex-so-called Amir also shall bear the consequences of his act. A mundane minister had to undergo all sorts of procedures so as justice be meted out, whereas the ex-so-called Amir is still being taken in honour especially when he has been found guilty of the charges against him. For an enquiry, a minister was required to undergo all sorts of questioning, whereas the ex-so-called Amir did not undergo questioning so that his evils may become manifest and justice be meted out.

Now, if a poor man had committed the fraud, everybody would have known about it in the Jamaat "in the blink of an eye". Announcements would have been done to humiliate such a person and he be handed over to the police (like witnessed in the past) – only because they are from modest families, not issuing from big (rich) families, but when the same thing happens to the so-called prestigious among them, each of them cover the dirt of their "friends", covering the dirt of their "ex-so-called Amir". But all these liberties (to commit evils) shall come to an abrupt end, and indeed shall prosper only those who safeguard their souls against such peoples and vain acts.
